In so doing, I release Surf Sherpa from all liability, including, but not limited to, liability for negligence, failure to warn, product liability and warranty arising out of or in any way connected with my participation in athletic activities. Furthermore, I promise and agree not to make any claim or commence

any lawsuit against surf Sherpa for injuries or damages arising from my participation in such activities or from the use of such equipment. As to the use of any equipment provided or furnished to me by Surf Sherpa. I expressly disclaim any and all warranties connected with such equipment. I have inspected and agree to accept such equipment "as is," and agree that there are no warranties with respect to such equipment which extend beyond the face of this agreement.
